2c	<p>DURING THE YEARS ENDED JUNE 30, 2008 AND 2007, THE COLLEGE WAS A PARTY TO TRANSACTIONS WITH A FINANCIAL INSTITUTION WITH WHICH A MEMBER OF THE BOARD IS AFFILIATED. THESE TRANSACTIONS INCLUDE DEPOSITORY ARRANGEMENTS, CUSTODIAL OR TRUST MANAGEMENT OF ENDOWMENT AND OTHE INVESTMENTS, AND LONG-TERM DEBT. THE FINANCIAL INSTITUTION IS ALSO THE UNDERWRITER FOR THE INDUSTRIAL DEVELOPMENT AUTHORITY BONDS AND TRUSTEE FOR THE RESERVE ACCOUNTS FOR THE DORMITORY BONDS. DEBT OUTSTANDING AT JUNE 30 PAYABLE TO THIS FINANCIAL INSTITUTION WAS \$7,157,000 AND \$7,583,000 IN 2008 AND 2007, RESPECTIVELY. THE RELATED INTEREST EXPENSE FOR THE YEARS ENDED JUNE 30, 2008 AND 2007 WAS \$439,000 AND 349,000, RESPECTIVELY. IN ADDITION, CERTAIN MEMBERS OF THE BOARD ARE ASSOCIATED WITH COMPANIES TO WHICH THE COLLEGE INCURRED THE FOLLOWING EXPENSES: COMMERCIAL INSURANCE AND WORKERS' COMPENSATION PREMIUM PAYMENTS OF \$416,600 IN 2008 AND \$381,500 IN 2007, CONSTRUCTION PAYMENTS OF \$430,000 IN 2008 AND \$250,000 IN 2007, LEGAL PAYMENTS OF \$1,000 IN 2008 AND \$1,400 IN 2007, AND ADVERTISING AND SUBSCRIPTIONS OF \$43,800 IN 2008 AND \$39,800 IN 2007.</p>
